- **Regulation (EC) 1935/2004** of 27 October 2004 concerning materials and articles intended to come into contact with food and repealing Directives 80/590/CEE e 89/109/CEE.
- **Regulation (EC) 2023/2006** of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food.
- Ministerial Decree of 21/03/1973 "Hygienic discipline of packaging, containers and articles intended to come into contact with foods or substances for personal use."

When used as specified, the overall migration as well as specific migration do not exceed the legal limits. The testing was performed according to DM 21/03/1973 and DM 174/2004.

- Test conditions: 2h, three successive attacks at 100°C with distilled water;
- Surface to volume ratio: 0,6 cm-1

The verification of compliance was performed based on the above rules; according Laboratory test on samples, which attest that the production complies with legal requirements subject to adherence to the stated conditions for contact with food.

Traceability of the product is ensured according to Regulation (EC) No 1935/2004 via the number printed on package related to the date of production.

In case of deviations from the intended use, the user is responsible for verifying compliance and suitability.
